PRESIDENT'S REPORT

As my second term begins . . .

New Town Hall still a nagging concern

y second term as your President began after a very successful AGM on May 30th. On the business side, the membership approved substantial amendments to the By-Law that better defines our mission statement and membership and allows your Board of Directors to properly operate and govern the affairs of the Association. I was very impressed with our members who attended (72) and took the three Councillors (Gamble, McGee and McKinlay) to task with some difficult questions of concern: the new Town Hall, Short Term Rentals and the Georgian Trail, to name a few.

The AGM was also successful on another front. We now have a new Director: Peter Seligman, who will provide a fresh outlook and bring new ideas to the Board. Peter is an independent estate and insurance planner who is keenly interested in helping the Association broaden and strengthen its membership base. Welcome aboard Peter.

THE NEW TOWN HALL development continues to be of concern to many of our members. Will the receipt of \$4.6 million in infrastructure money provide relief to taxpayers? I don't think so. While the Mayor sings a chorus of "We're in the money," the Town's own auditor sings "Fix your negative reserve funds and reduce your capital spending." The Town currently has 10 reserve funds showing deficits of \$6,123,034 money that has been taken out of important infrastructure funds to finance capital for pet projects. If the Town can't replace this money from development charges - guess who pays?

The new Town Hall is already running over budget; remediation

costs for the old service will be in excess of \$100,000, far more than promised by the CAO, and there are new plans for a staff parking lot on the old trailer park site. This doesn't include the storing of contaminated soil for free at our dump.

Finally, the Town's steering committee is now trying to spin the excavation and remediation costs into a great opportunity to build a full basement which will provide for more bureaucratic space. The extra costs are not known but another \$500,000 wouldn't be out of the question.

My biggest concern, however, is not about construction costs, but how we are going to pay for the maintenance of this much larger building without subtracting other facilities and raising taxes, water and sewer rates and a number of user-fee charges.

We will be following all these costs and keep you informed, especially as the construction date gets closer.

Accommodation issue, an OMB Pre-Hearing Conference was held on July 28, 2009 and a list of seven volunteers was presented and accepted by the Board to participate as "witnesses" in support of the Town's Official Plan and Zoning Amendments. Unless the participating parties come to some settlement, a hearing is expected to be scheduled for late winter or early spring. State tuned!!!

On another front, the Blue Mountains pilot "Neighbourhood Watch Program" was launched in the Craigleith Community Centre at a meeting held on August 22, 2009. I will temporary serve as the neighbourhood's area coordinator and we have four volunteers (so far) to serve as zone coordinators. These zone coordinators are in the process of canvassing the streets and signing up watch members.

As soon as we organize and finalize all the details (i.e., handing out decals, erecting strategic metal signs, distributing valuable instruction materials and phone numbers, etc.), we will start the process of branching out to other neighbourhoods. The "Neighbourhood Watch Program" will be one of several types of watch programs under the greater Commu-

nity Watch umbrella, which is expected to reach out to all areas of the Town.

I would also like to mention that the Board is continually looking for areas to expand the Association's membership base and provide a stronger voice in the affairs of the community. In this regard, the Board passed a motion to amend the By-Law to include a "Condo Membership," which will be extended only to Condo Executive Directors. These Directors will be responsible for dispersing all newsletters and email blasts to all residential unit owners within the Condo Corporation. Residential unit owners will still be encouraged to join the Association as separate members.

I can proudly inform you that we have two Condo memberships already, representing 67 residential units, and we expect to receive another four memberships soon.



The dreaded Harmonized Sales Tax plan (HST)

Ontarians resent Premier McGuinty's proposed merger with GST, poll shows

The following article/poll was published in the Toronto Star this past May, clearly indicating that a majority of Ontarians reject this legislation:

Premier Dalton McGuinty's harmonized sales tax is more than a year away but Ontarians already resent it, a new survey suggests.

Even though consumers will not be paying the 13% levy until July 1, 2010, there is growing anxiety about the tax's impact on pocketbooks, according to a Nanos Research poll done for the *Toronto Star* and *La Presse*.

"It's pretty clear that Ontarians are concerned about the potential negative effects of harmonization," company president and CEO Nik Nanos said vesterday.

Nationally, 48% of Canadians see tax harmonization as a negative move while 34% believe it is positive and 18% are unsure. (Quebec, Nova Scotia, New Brunswick and Newfoundland have already harmonized their consumption taxes.)

But in Ontario, 67% of people polled have a negative view of the melded tax compared to 23% seeing it as positive and 10% unsure.

Nanos Research interviewed 1,001 people across the country from April 25 to 30 and results are considered accurate to within 3.1 percentage points, 19 times out of 20.

In Ontario, 302 people were surveyed and provincial results are accurate to within 5.7 percentage points, 19 times out of 20.

Across Canada, 28% felt the business-friendly

streamlined tax would boost Ontario's struggling economy while 32% feared it would hurt the province with 25% neutral and 16% unsure. In Ontario, 21% believe it will be positive and 51% said it would have a negative effect with 21% neutral and 7% unsure.

McGuinty wasn't available to the *Star* yesterday, but he recently noted that Ontarians aren't yet that aware of the fact the 8% provincial sales tax is being melded with the 5% GST.

"I think most folks haven't heard about it. Human nature being what it is, we live in a 1,000-channel universe; it's swine flu, it's the world recession, it's the auto sector, all those kinds of things," the premier said last month.

"As we get closer to July of next year then they're going to stare into the face of it and better understand what it's all about," he said April 29.

Nanos said the government is going to have to explain the intricacies of a tax reform that will raise the levies on everything from a morning coffee and muffin to gasoline and heating fuel to funerals and new homes costing more than \$500,000. "Otherwise, they could be in for a very rough ride."

The Liberals clearly appreciate that challenge, which is why the government is lobbying the auditor general to loosen the rules against partisan political advertising.

It is believed McGuinty hopes to launch an ad blitz in the run-up to July 1, 2010 touting the \$1,000 in rebate cheques that most families will receive from the federal government to offset the higher costs of numerous products and services.

Mr. McGuinty explains . . .

One of our members took the time to write to Mr. McGuinty's office about the Province's proposed "TAX GRAB" and its unfairness to the taxpayers, especially low income families. His appeal to Mr. McGuinty and his "Liberal henchmen" that they come to their common senses resulted in the following bureaucratic response, which we want to share with you:

Thanks for writing to me about the proposed single sales tax. Your views are important and they matter to me. And I appreciate your taking the time to express them.

I'd like to take this opportunity to tell you why our government is making these important changes. It's all about building a stronger economy for Ontario.

Merging the GST and the PST on July 1, 2010, is

the single most important step we can take to make Ontario more attractive to businesses. As already proven in the Atlantic provinces, a single sales tax will mean more business investment in Ontario and, ultimately, more jobs for Ontarians.

By merging two taxes with different rules into one sales tax with one set of rules, we're reducing red tape — and creating new incentives for Ontario businesses to grow and for new businesses to locate here.

I know this change will not be easy. That's why we're doing our part to make the transition as smooth as possible for families across the province.

Our full package of tax changes includes personal income tax cuts and small business tax cuts. In fact, 93 per cent of all Ontario taxpayers will benefit from a personal income tax cut next year.

Our tax changes will leave our government with \$2.3 billion less revenue over the next four years. While that shortfall will create its own set of challenges, we feel strongly that it's a price worth paying if we truly want Ontario to prosper.

I know many Ontarians are feeling the effects of the current global economic recession. But I am confident that, if we work together, and are prepared to make changes now to help our economy, Ontario will emerge an even stronger, more prosperous and more beautiful place for our children and grandchildren.

Governance of our association

Over the past year, it was decided that our By-Law was outdated and did not allow the Board of Directors to properly operate and govern the affairs of the Association. After much deliberation and re-writing of the old By-Law, the amended Association By-law was presented for approval at the AGM held on May 30.

The following is a list of the major changes:

- The format has been changed to a point and number format (i.e., 2.1, 2.2, 2.3, etc.) which makes it easier to read and to make amendments in the future without rewriting the whole section;
- All references to the Craigleith Community have been taken out; the business affairs of the Association now pertain to all members within the Town of the Blue Mountains;
- Article 3 The Board of Directors has been reduced to a minimum of 5 directors instead of 8;
- Article 10 The Secretary and Treasurer are now considered two separate officers of the Association;
- Article 19 New Conflict of Interest and Confidentiality section;

- **Article 20** New Protection of Directors and Officers section;
- Article 21 New Membership section to reflect two types of memberships a Family Membership and a Company Membership.

There are many small or minor "housekeeping" changes – mostly wording and to reflect the type of memberships.

Motion to adopt and approve the BMRA governing By-Law, as amended and presented by Michael Seguin, was moved by member Brian Lane and seconded by member Steve Donahue. Motion carried.

The amended By-Law can be viewed on the BMRA web site at any time or you can request a hard copy by writing to BMRA, Box 405, Collingwood, ON, L9Y 3Z7.

In brief:

- Grey County wants to pave the shoulders on County roads in order to provide for increasing pedestrian traffic (walking and cycling), and are studying the cost-benefits;
- The Blue Mountains has approved a final Fire Master Plan and has given the department the goahead to hire three new officers, increase the volunteer firefighter component and create two new positions; this will cost the taxpayers \$117,500 in 2009, \$363,300 in 2010 a 1.4% tax increase, \$411,600 in 2011 a 1.1% tax increase, and \$490,000 in 2012 a 1.2% tax increase. The hiring of three new officers this year is suppose to improve response to emergency calls and allow for more inspections, fire code enforcement, defibrillator training, public education duties, pre-emergency planning and maintenance responsibilities.
- The Town is re-writing its zoning by-law to consolidate the old Township of Collingwood and Town of Thornbury by-laws. The public is being asked to participate in advising of their concerns. The process is expected to be completed by January, 2010.

Georgian Bay Animal Rescue:

Ten years of caring for Georgian Triangle's needy animals

This year, Georgian Bay Animal Rescue (GBAR) reached the milestone of 10 years of service and care of the needy animals in the Georgian Triangle, a very large area to cover for a group of unpaid volunteers who work without any municipal or government support. And as a "No Kill" animal rescue registered charity, there is additional strain put on limited resources, though GBAR firmly believes it is the humane, compassionate way to deal with the hundreds of abandoned, unwanted, neglected, sick, injured animals found yearly, many in the Blue Mountains.

There has never been an animal shelter within the Georgian Triangle. TOBM uses Blue Mountain

Veterinary Services as the town pound — but only for dogs, which are housed for seven days at the town's expense (costs are charged back to the owner of a claimed dog). After this time, unclaimed dogs are to be "disposed of," since the town takes no further responsibility for them. (See TOBM By-law No. 2006-32; in particular Sections 14.0 Seizure and Impounding; Section 15.0 Liability for Fees; Section 16.0 Disposal of Dogs.)

Fortunately, Dr. Tina Gray has a heart, and using her own finances keeps these unfortunate dogs until a home can be found for them. GBAR's website provides courtesy listings for

this purpose. Sadly, the situation is no better in the other municipalities within the Georgian Triangle. And "felines," as the Town so poetically calls cats in its public notices, are not provided for in any way by TOBM. We quote:

"Please be advised that the Municipality does not provide and/or have facilities related to felines. You are reminded that felines are not to be dropped off at the Town's shelter. By-law Enforcement: (519) 599-3131 Ext. 249."

Injured, sick, abandoned cats are left to fend for themselves; many are also pregnant. The town takes no responsibility for these poor, unfortunate creatures who find themselves in these situations through no fault of their own; they are the result of human neglect, abuse and indifference.

It is GBAR that takes all of these animals into its compassionate care, which has resulted in about 400 cats in care; and in 2008, \$228,000 in veterinary expenses! And even though TOBM makes no provision for the care of felines/cats, it recently issued an

eviction order for GBAR's cat shelter at 104 Hope Street, a property which is zoned Highway Commercial, which permits the operation of a veterinary clinic with boarding for dogs and CATS! (Final outcome of this situation is not clear at time of writing.)

Because of the absense of an animal shelter in the area, GBAR has been working to have one built. And although groundbreaking was in January, 2008, a year and a half later the building is still not completed because of lack of funds. Construction has slowed due to tough economic times and fundraising realities: funds dried up, and are slow in coming in.

The struggle to reach completion and opening of the shelter continues. Between \$350,000 and \$500,000 is needed now to get the shelter open.

Minimal amounts have been contributed by the municipalities that will benefit by the operation of this animal shelter. For example, an affluent municipality such as TOBM (where the average house sale price is over \$350,000, according to the local real estate

board, higher than any other municipality within the Georgian Triangle, and similar to Toronto's, creating high assessment valuations for its tax base), has not extended itself very much for the care of its abandoned animals. In May, 2008, it made a total contribution of \$15,000 towards the Shelter Building Fund – this for a building that will cost at minimum \$1-million to build and furnish and which will be at least 30% occupied by animals from TOBM! Council can find large amounts of money for all sorts of things, including a grand new town hall, but not to help alleviate the suffering and plight of its needy animals.

During 2008 and to date in 2009, as donations warrant, work has moved slowly forward toward the day when the Shelter's doors can proudly swing open. The Design/Build contractor — Shertine Construction of Collingwood (owner, Les Burgess) — generously accelerated work on the Shelter during June/July to complete the building to the point where an Occupancy Permit could be obtained. This work was done with the understanding that GBAR would pay on an "as we can, when we can" basis, with ongoing fundraising efforts, and that the financial costs to Shertine would be considered as part of their overall corporate contribution to the Shelter project.

But even with this boost, some items will not be finalized and must be completed later. These include landscaping; a retaining wall at rear of dog runs; interior/exterior details of dog runs; cat enclosures; signage, and other miscellaneous items. And funding is still needed for the interior fittings and fixtures.

Serious fundraising is still required to reach the final stage of the Shelter.



When completed, this first purpose-built Shelter in the Georgian Triangle will be an achievement all of the community can be proud of. Still much needed is the ongoing generosity, help, dedication and support of the public who share GBAR's dream and goal for the benefit of the needy animals in our community, that depend on human kindness and that we cannot let down.



Town receives Gas Tax money from the Feds

In April, Simcoe-Grey MP Helena Guergis announced that the Conservative government would double Gas Tax transfers to municipalities. Your Town has been approved for \$198,728.02 in 2009 and \$209,937.00 in 2010. Ms. Guergis stated that the new money is to help pay for projects such as roads, water, sewer and public transit improvements. Your Town has found a way of spending this money - a roundabout, landfill environmental screening, waste receiving area and you won't believe it! - the integrated community sustainability plan (ICSP). The Town commits \$250,000 to proposed Medical Clinic

The North East Grey Health Clinics Inc. (NEGHC) approached Council in April for financial support. Town purchases neighbouring land for long-term expansion of the Library

The Town has approved the purchase of a residential property (177 Bruce Street) on the south side of the Library for \$244,000. We understand that the appraised value was \$210,000, but no reasons were given as to why the Town paid more than the appraised value. The funds are to come from the library's development charges reserve fund, which is currently at \$375,662.04. Councillor Gamble argued against the acquisition on the basis that the lands to the south of the library did not reflect the original design and plan for the library. *Source: Courier-Herald* 6/3/09

Town wants to pave the Georgian Trail

In May, the Town's Recreation Department together with the Georgian Trail Board of Management decided to apply to the Recreation Infrastructure Canada Program (RInC) for funding to complete the hard surfacing (asphalt paving) of the entire 34 km Georgian Trail. Councilor Gamble presented this proposal to Council with the suggestion that additional funding would be required from the Town without public input (not sufficient time). However, at our AGM, some of our members expressed anger and disappointment that the Town would consider such an "inappropriate" proposal without consulting the public, especially those who use the trail on a regular basis. The Courier-Herald carried a number of interesting comments and "protests" discouraging this type of behaviour. Interestingly, only the major writer for the paper, Ms. Engel, showed support for the pavement. Source: Courier-Herald 5/28/09 and 6/3/09

(On July 14, it was announced that the paving project for portions of the Georgian Trail had been denied funding by the RInC and that a reserve fund of \$200,000 will be used to make some repairs and resurface the trail in 2009.)

The Blue Mountains "In the Money"

On June 13 it was announced that the federal and provincial governments will invest approximately \$7.6 million towards infrastructure projects: \$4.6-million for the new Town hall, \$332,000 for a trail along Beaver River from Thornbury to Clarksburg and \$2.6 million for the replacement of water and sewer service and road infrastructure in Plan 915. The mayor was so happy, she started singing a chorus of "We're in the Money" – I think from relief about not having to pass on the huge costs of these projects to the taxpayers. Hopefully, the Town can stay within their projected budget and not use this money to enhance their projects with more "bells and whistles." *Source: Courier-Herald 6/17/09*
